This notice is for the Hill College branch campus maintenance tax assessed and levied by the Joshua ISD (hereinafter referred to as Hill College – Joshua ISD)

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for Hill College - Joshua ISD from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval tax rate is the highest tax rate that Hill College - Joshua ISD may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Hill College - Joshua ISD is proposing to increase property taxes for the 2020 tax year.

A public hearing on the proposed tax rate will be held on August 31, 2020 at 5:30 PM at the Joshua ISD Board Room 310 E. 18th Street Joshua TX 76058.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Joshua ISD is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the School Board of Joshua ISD at their offices or by attending the public meeting mentioned above.
